

## **Competition Terms and Conditions**

### **The Promotion**

Whitsunday Regional Council t/a Whitsunday Coast Airport the 'Promoter' is running a Promotion where the following prize pool is available to WIN:

For two (2) people:

- a) Direct return airfares from Whitsunday Coast Airport to Adelaide Airport with Jetstar Australia;

## **Determination and Notification of Winner**
